It is expressly agreed and understood by the undersigned that the term "personal injuries" as used herein includes not only all claims arising out of bodily injuries sustained by the undersigned but also includes any and all claims for expenses incurred on behalf of a spouse or minor child, loss of consortium, loss of services or wrongful death of another resulting from said accident or occurrence.
